This is unacceptable. I hereby request that the meeting minutes reflect the fact that I sent in a request to make a presentation within the deadline for such requests, and that despite proof of email being shown at the meeting to both Mike Singh and Larry Rolfes before the meeting began, my request was not respected. 35 minutes of presentation by Ms Rowe that had nothing to do with public process was allowed and went uninterrupted yet my request...again, was disrespected. My request for presentation was denied without cause and instead I was interrupted and cut off, told I had to present a conclusion when in fact it was a public comment period. I showed that proof both to Mr Rolfes and Mr. Singh and also sent digitally [again] the following day, yet it is not reflected on the IRP website or acknowledged. Mr Singh refused to admit to the conversation, so you can expect a report that includes audio proof of both Mr. Singh's acknowledgement before the meeting. It was that in-my-face betrayal that led me to the extreme feeling of hopelessness, in front of everyone, and that my 10 minutes would not be honored, yet again despite nearly two decades of work on this. Ms Rowe has declared me invisible, and written to every level of government to disparage me, and here again a decade later, this preferential treatment to those fawning over DTSC continues. I have felt so disrespected by DTSC's ignoring laws, ignoring requests for information and use of a paid-for CAG to. Lie to the community for them. It is disgusting and has been going on for years including cyber-bullying on an incessant level. I expect these facts to be included in the public record of this meeting and not to have it reduced to more lies. I have rights too, and mine have been violated including libel. Erasing the dtsc actions yet again, just shows how non-independent this really is. That is why that happened after so many years of being treated disrespectfully by DTSC by their refusal to be honest or responsive--years of being ignored and disrespected by DTSC including multiple filed complaints of violations of chapter 6.8 of the health and safety code that were wholly ignored by the agency's public participation department and management of the project. The use of bullying and slander to keep the public at bay are unacceptable tools of public control, and lead to extreme disheartening as seen by all the comments that evening. No matter who it was, they all agreed that DTSC has failed on a systematic and institutional basis.

It's time to clean house and have real accountability, not this white-wash bull to protect the agency you are supposed to be investigating. I heard how disappointed the director was in her testimony and apparently shows her continued influence. From the top, just like Linda Adams rule by bullying and intimidation. I will continue to expose all of it.
