Notice the shape, notice how people listen to each other. People participate. You can see who is on the board. The facilitator has rules and is in control of the room, not by grabbing the mic out of people's hands like DTSC does, but by declaring rules of participation and having the participants agree to those rules. It's public participation 101!

In fact, DOE meetings look like this. NASA meetings look like this. Even Boeing meetings look kind of like this and it's just DTSC meetings that look like a circus of anger and cover-up and incompetency. Keeping people moving so they cannot ask questions, making questions the enemy when the whole ENTIRE point is to have people gain a shared understanding of the issues, positions, and decisions to be made.

You can see documents and what kind of questions about issues people have. The questions are addressed, not creating hate videos about the people they don't want to hear from. It's not that hard.
