WHAT IS BEING PROPOSED? - The Department of Toxic Substances Control (DTSC) invites you to review and comment on the draft Remedial Action Plan (RAP) and CEQA environmental documents for the cleanup of groundwater at the former Whittaker-Bermite Facility located at 22116 West Soledad Canyon Road, Santa Clarita, CA 91355.

CALIFORNIA ENVIRONMENTAL QUALITY ACT – MITIGATED NEGATIVE DECLARATION — DTSC evaluated potential environmental impacts associated with the proposed draft RAP for the groundwater (known as OU-7), as required by the California Environmental Quality Act (CEQA). DTSC has prepared an Initial Study (IS) and Mitigated Negative Declaration (MND), which discloses the potential environmental impacts of the draft RAP. This IS/MND is available for public review in the information repositories listed below.
