## Attachment 1.

### Explanation of Column Headings For the Permitted Facilities Financial Assurance Data Spreadsheet

The following is a description of each column heading within the spreadsheet:

**Facility Name** – This column provides the name of the facility.

**EPA ID Number** – This column provides the Facility’s Environmental Protection Agency Identification Number.

**Regulatory Status** – This column identifies the regulations governing the permit. It includes either RCRA, Standardized, or State Only permit regulations as defined below.

**Resource Conservation and Recovery Act (RCRA)** – RCRA permits are issued in accordance with California Code of Regulations, Title 22, Division 4.5, Chapter 20. These permits are issued for hazardous waste treatment, storage, and disposal facilities that are required to have a permit under RCRA.

**Standardized Permits** – Standardized Permits are issued in accordance with California Code of Regulations, Title 22, Division 4.5, Chapter 20, Article 6.5. These permits are for treatment or storage activities that do not require a RCRA permit, but may be eligible for a Standardized permit in California pursuant to section 25201.6 of the Health and Safety Code.

**State Only Permits** – Facilities not eligible for Standardized permits are permitted in accordance with California Code of Regulations, Title 22, Division 4.5, Chapter 20. For example, a used oil treatment facility would require a State Only permit.

**Closure Mechanism Type** – This column identifies the type of mechanism (see attachment 2. for mechanism definitions and acronyms). State and federal facilities are exempt from financial assurance requirements.

**Closure Amount** – This column provides the amount of available funds in the financial assurance mechanism.

**Post-Closure Mechanism Type** – This column identifies the type of mechanism (see attachment 2. for mechanism definitions and acronyms). State and federal facilities are exempt from financial assurance requirements.

**Post-Closure Amount** – This column provides the amount of available funds in the financial assurance mechanism.

**Facility Status** – See Attachment 3 for further explanation.

## Attachment 2.

### Description of DTSC Financial Assurance Mechanisms and Acronyms for Operators and Owners of Hazardous Waste Facilities

**Trust (TA)** - A trust fund is an account created by a hazardous waste facility with a trustee for the benefit of DTSC. The Trust Fund allows DTSC to control the fund if the owner or operator fails to meet its financial assurance obligations. A trust fund is created with money placed into an account. For closure and post-closure care, the hazardous waste facility may make annual payments into the fund for up to ten years. This time period is called the “pay-in period.” Trust funds established for third party liability must be fully funded. A trust fund is managed by a trustee (usually a bank) licensed or chartered by a state or federal agency. A trust fund may be used for closure, post-closure, corrective action, and third party liability.

**Letter of Credit (LOC)** - A letter of credit is guarantee by a financial institution (a bank) that covers the owner’s or operator’s financial assurance requirements. A letter of credit is similar to a “line of credit”; that is, it is meant to provide assurance that the applicant will meet its financial obligation. A standby trust fund is required with the letter of credit to provide an account into which the funds drawn from the letter of credit may be deposited. A standby trust with a letter of credit for third party liability is optional. There are severe financial penalties for the owner or operator if the letter of credit is drawn upon (e.g., reduced or ruined credit rating), therefore it is always preferable for an owner or operator to meet its obligations without requiring DTSC to draw upon this mechanism. A letter of credit may be used to provide financial assurance for closure, post closure, corrective action, and third party liability.

**Surety Bond (SB)** - Surety bonds are guarantees by a third party that closure, post-closure and corrective action obligations will be fulfilled. Surety bonds may also be used for liability coverage. There are three types of surety bonds:

1. **Financial Guarantee Bond (SB/F)** - in the event an owner or operator fails to fulfill closure and post-closure requirements, a financial guarantee bond funds a standby trust in the amount equal to the face value (also known as the “penal sum”) of the bond.
2. **Performance Bond (SB/P)** - Guarantees that the owner or operator will perform final closure (or post-closure care, or corrective action) in accordance with the closure plan (or post-closure plan) and other requirements of the permit for the facility. The surety shall become liable on the bond obligation only when the owner or operator fails to perform as guaranteed by the bond. A performance bond may not be used for third party liability.
3. **Payment Bond** - is a form of surety bond used for third party liability coverage. Surety bonds are issued by surety companies (usually subsidiaries of insurance companies). To

be acceptable, a surety company must be on a list that shows they are authorized by the US Treasury Department to issue Treasury Bonds. This list is known as Circular 570.

**Insurance Policy (Ins)** - An insurance policy is a guarantee that funds shall be available in an amount equal to the face value of the policy to meet financial assurance requirements. An insurance policy may provide funds for closure, post-closure, corrective action, and third party liability.

**Financial Test (FT)/Corporate Guarantee (CG)** - An owner or operator (a corporation) presents their financial statements as demonstration that they have adequate financial resources to meet their financial assurance obligations. That is, an owner or operator provides a certification that their assets meet or exceed the costs of their obligations (financial assurance requirements plus current liabilities). An independent certified public accountant's statement must accompany this certification. A "corporate guarantee" is a financial test that is a written guarantee from a direct or higher-tier parent corporation, a firm whose parent corporation is also the parent corporation of the owner operator, or a firm with a "substantial business relationship" with the owner or operator to perform closure, post-closure, corrective action, or pay liability claims if the owner or operator fails to do so. The corporate guarantor must meet or exceed the financial test.

**Alternative Financial Mechanisms** - An alternative mechanism is a financial assurance mechanism other than those specifically mentioned in regulation. The alternative mechanism must be at least equivalent to the other financial mechanisms listed in regulation. The typical alternative mechanism DTSC accepts is a Certificate of Deposit (**CD**).

There are 118 permitted Hazardous Waste Management Facilities. The permitted facilities that have financial assurance for corrective action have been identified on the Financial Assurance Data Spreadsheet under "Facility Status." Financial assurance for corrective action may be included in the financial assurance for post-closure care in accordance with Title 22 of the California Code of Regulations, Division 4.5, Chapter 14, Article 6 – Water Quality Monitoring and Response Programs for Permitted Facilities, or under an Operation and Maintenance Order

or Agreement. The Financial Assurance Data Sheet has a full accounting of the status of each of the 118 permitted facilities as described below.

Of the 118 permitted facilities, 88 have known contamination and are in various stages of investigation and corrective action.

- 9 of the 88 facilities are Standardized or State permits for small facilities that are not regulated under the Resource Conservation and Recovery Act (RCRA) and are required to perform a Phase I Environmental Assessment pursuant to California Health and Safety Code § 25201.6(i)(1) to determine if Corrective Actions are necessary.
  - Three of the nine facilities have already implemented corrective actions.
  - One of the nine facilities has been referred to another agency for further action.
  - Two of the nine facilities have been investigated and require no further action.
  - Three of the nine facilities are under investigation and will be evaluated to determine if financial assurance for corrective action should be required prior to determining the full extent of contamination, evaluating remedial alternatives, or determining the appropriate remedy.
- 79 of the 88 facilities have full RCRA Permits that require investigations, feasibility studies, corrective actions, and monitoring to remediate past and present releases of hazardous waste to soil, air, surface water, and groundwater.
  - 10 of the 79 facilities are federal facilities that are exempt from the requirements for financial assurance.
  - 35 of the 79 facilities are already implementing corrective actions and 4 additional facilities are scheduled to implement corrective action in the next two years.
  - 16 of the 79 facilities have been referred to either the U.S. EPA or the Regional Water Quality Control Board (RWQCB) for further action.
  - 4 of the 79 sites were investigated and did not require further corrective actions.
  - 10 of the 79 facilities are undergoing investigation to determine what corrective actions are necessary.
    - 4 of these 10 facilities have financial assurance for post-closure care that can be increased for corrective actions if necessary.
    - 6 facilities will be evaluated to determine if financial assurance for corrective action should be required prior to determining the full extent of contamination, evaluating remedial alternatives, or determining the appropriate remedy.

There are no facilities with unknown contamination.

There are 30 facilities that do not have contamination. Of these 30, 2 are exempt from financial assurance requirements, 5 are RCRA permits with no contamination, 3 are State permits with no contamination and 20 are Standardized permits with no contamination.

The IRP Response ID number on the table above is used to identify the individual facilities that meet the IRP Response Category on the Attached Financial Assurance Data Sheet.
