Background: The IRP was established by SB 83 (Statutes of 2015, Chapter 24) to: (1) advise the DTSC on issues related to its reporting obligations; (2) make recommendations for improving DTSC's programs; (3) advise DTSC on increasing the levels of environmental protection by its programs; and (4) report to the Governor and the Legislature.

Meeting Purpose:

This is the first meeting of the IRP. The meeting will cover:

- Informational materials related to the goals and operational aspects of the IRP.

The IRP will also meet in closed session to discuss matters related to the appointment, evaluation of performance, or dismissal of a public employee.
