



NOTICE OF PUBLIC COMMENT PERIOD

Revised Draft Standardized Hazardous Waste Facility Permit And Revised CEQA Draft Negative Declaration for Clean Harbors San Jose, LLC, Rail Spur Transfer Facility 660 Lenfest Road, San Jose, California 95133-1614



What is being proposed?

The Department of Toxic Substances Control (DTSC) invites the public to review and comment on the revised Draft Standardized Hazardous Waste Facility permit (Revised Draft Permit) and the revised Draft Negative Declaration for Clean Harbors Rail Spur Transfer Facility (Lenfest Rail Facility) located in San Jose. For the first draft Permit, DTSC published a public notice in San Jose Mercury News on October 4, 2005. DTSC also held a 45-day public comment period from October 4, 2005 to November 18, 2005 for both the first draft Permit and the draft California Environmental Quality Act (CEQA) Negative Declaration. Public comments were received; at the end of public comment period, Clean Harbors re-designed its containment system to comply with the requirements of the City of San Jose's Fire Department. Therefore, DTSC revised the Draft Permit and the Initial Study and has reopened the public comment period for the Revised Draft Permit and Revised Draft Negative Declaration which are available on DTSC's website and at the repositories for review.

The Permit, if approved, will allow the Lenfest Rail Facility the following activities:

- Continue the transfer of bulk liquid hazardous wastes originating from Clean Harbors San Jose, LLC located at 1021 Berryessa Road, San Jose, California (Berryessa Facility) to the rail tank cars at the existing Lenfest Facility.
- Construct a concrete pad 33 feet away from the existing warehouse for a tanker/vacuum truck.
- Construct a below grade 27,000-gallon sump adjacent to the concrete pad as spill containment.
- Install four sets of track pan systems below the rail tracks as spill containment for four rail tank cars.
- Conduct soil sampling according to a DTSC-approved sampling plan before any construction begins to determine if there are no prior hazardous waste constituent releases.
- Install and operate a vapor recovery system for use during transfer of bulk liquid hazardous wastes

How do I participate?

Your participation is encouraged. The 45-day public comment period begins on June 15, 2007 and ends on July 30, 2007. You may comment on the Revised Draft Permit and Revised Draft Negative Declaration by sending written or e-mailed comments to:
