**NOTICE OF FINAL HAZARDOUS WASTE FACILITY PERMIT DECISION –  
EVERGREEN OIL, INC. – SANTA MARIA, 745-A WEST BETTERAVIA ROAD,  
SANTA MARIA, CALIFORNIA, EPA ID No. CAD 982446858**

In accordance with the requirements of California Code of Regulations, title 22, section 66271.14, the Department of Toxic Substances Control (DTSC) is issuing this Notice of Final Hazardous Waste Facility Permit Decision (Notice) for the following facility:

Evergreen Oil, Inc. – Santa Maria  
745-A West Betteravia Road  
Santa Maria, California 93454  
EPA ID No. CAD 982446858

This Final Standardized Hazardous Waste Facility Permit authorizes Evergreen Oil, Inc. to continue to store and transfer used oil, waste antifreeze, non-RCRA wastewater, and solid wastes contaminated with oil at its facility located 745-A West Betteravia Road in Santa Maria, California. On July 2, 2008, DTSC published a public notice in the Santa Maria Times (an English language newspaper) and the El Tiempo (a Friday-only Spanish language newspaper) on July 4, 2008 to announce the start of a 45-day public comment period to solicit comments on the Draft Permit and the Draft Negative Declaration. The public comment period ended on August 15, 2008. Public comments were received by electronic mail and postal mail.

DTSC has prepared a Response to the Comments (RTC) document and made some changes to the Draft Permit. The RTC document and the DTSC memorandum to file listing the changes from the draft to the final Permit are available for formal public review at the repositories listed at the end of this Notice.

The Final Standardized Hazardous Waste Facility Permit, Series C, becomes effective on January 15, 2009 unless a review is requested pursuant to the California Code of Regulations, title 22, section 66271.18. Any person who filed

comments on the draft permit or participated in the public hearing may petition DTSC to review any conditions of the permit decision. Any person who failed to file comments on the draft permit may petition for administrative review only to the extent of the changes from the draft to the final permit. The petition shall include a statement of the reasons supporting that review, including a demonstration that any issues being raised were raised during the public comment period to the extent required by the regulations and when appropriate, a showing that the condition in question is based on:

1. A finding of fact or conclusion of law which is clearly erroneous, or
2. An exercise of discretion or an important policy consideration which DTSC should, in its discretion, review.
