**NOTICE OF FINAL HAZARDOUS WASTE FACILITY POST CLOSURE PERMIT

In accordance with the requirements of California Code of Regulations, title 22, section 66271.14, the Department of Toxic Substances Control (DTSC) is issuing this Notice of Final Hazardous Waste Facility Post Closure Permit Decision (Notice) for the following facility:

Forward Landfill, Waste Management Unit A (WMU-A)
9999 South Austin Road
Manteca, CA 95336
EPA ID No: CAD990794133

This Final Hazardous Waste Facility Post Closure Permit authorizes Forward Landfill to maintain post closure operations for the closed hazardous waste landfill unit, WMU-A, at 9999 South Austin Road in Manteca, San Joaquin County, California. Waste Management Unit A's post closure operations are maintained in accordance with the requirements of California Code of Regulations, title 22.

DTSC has prepared a Response to Comments (RTC) document and made some minor grammatical and illustrative changes to the Draft Permit. Because comments requested grammatical and illustrative changes to the Draft Permit, the Final Permit becomes effective 30 days after the Final Permit Decision, in accordance with California Code of Regulations, title 22, section 66271.18. Any person who filed comments on the Draft Permit may petition DTSC to review any condition of the permit decision. Any person who failed to file comments on the Draft Permit may petition for Administrative Review only to the extent of the changes from the Draft Permit to the Final Permit. The petition shall include a statement of the reasons supporting the review, including a demonstration that any issues being raised were raised during the public comment period to the extent required by the regulations and when appropriate, a showing that the condition in question is based on:

1. A finding or fact conclusion of law which is clearly erroneous, or

2. An exercise of discretion or an important policy consideration which DTSC should, in its discretion, review.
