ALLOW THE RELEVANT CERTIFIED UNIFIED PROGRAM AGENCIES (CUPA) HAVING JURISDICTION OVER ANY OF THE RECYCLE DEPOT'S FACILITIES TO ENTER ONTO SUCH FACILITIES WITHOUT NOTICE DURING DAYTIME HOURS TO INSPECT FACILITIES FOR VIOLATIONS OF THE HAZARDOUS WASTE CONTROL LAW AND ANY REGULATIONS PROMULGATED THERETO
