TERMINATION OF CORRECTIVE ACTION FORMER OLIN-HUNT SPECIALITY PRODUCTS Vernon, California

WHAT IS BEING PROPOSED? The California Environmental Protection Agency, Department of Toxic Substances Control (DTSC), is legally required to inform the public of the intent to terminate corrective action at the Former Olin Hunt Specialty Products facility, located at 4225 Charter Street, Vernon, California 90058.

Olin Hunt Specialty Products operated from 1961 until 1984. The facility engaged in the treatment, storage and production of ferric chloride and chromium sulfate etchants. In 1965 the facility expanded its operation to the formulation and packaging of chemical solutions used in the photographic industry. In 1993, the City of Vernon oversaw the removal of underground storage tanks and associated piping. DTSC then became involved and entered into a Corrective Action Consent Agreement with the Olin Corporation when it was determined that previous operations resulted in chemical releases to the environment.

Between 2005 and 2011, extensive sampling of groundwater, soil, soil vapor and indoor air sampling was conducted at the former Olin Hunt facility. The results of this sampling were used to complete a risk assessment and make a determination that the residual chemicals do not pose a risk for industrial workers located at the site. A land use covenant was recorded to ensure that the property will only be used for industrial or commercial uses. The facility is currently used as a warehouse. DTSC is now public noticing the intent to terminate corrective action for this site.
