**NOTICE OF PUBLIC HEARING AND PUBLIC COMMENT PERIOD
ON DRAFT PERMIT AND
DRAFT ENVIRONMENTAL IMPACT REPORT**

The Department of Toxic Substances Control (DTSC) invites your comments on the draft Hazardous Waste Facility Permit (Draft Permit) and a Draft Environmental Impact Report. If approved, DTSC would renew the Romic Environmental Technologies Corporation (Romic) permit to store and treat hazardous waste at its facility, 2081 Bay Road, East Palo Alto. This permit would be in effect for ten years.

Romic operates a hazardous waste recycling, storage and treatment facility. They plan to store and treat wastes in 138 tanks. In addition, there are 28 treatment units to be used by Romic. The Draft Permit includes a number of existing treatment processes and units. They include solvent recycling, fuel blending, lab packing, and antifreeze recycling. New treatment processes in the Draft Permit include crushing contaminated drums, washing contaminated tanker trucks, and depressurizing aerosol cans, dewatering and stabilizing sludge and consolidating and repacking solid waste. You may comment on any aspect of the Draft Permit.

Under the California Environmental Quality Act, DTSC must evaluate whether the proposed actions may have any significant impacts on the environment. In order to do this analysis, DTSC has prepared a Draft Environmental Impact Report (Draft EIR).

The 60-day public comment period begins May 31, 2005, and ends July 29, 2005.
