PUBLIC COMMENT PERIOD: AUGUST 21, 2007 – October 4, 2007

WHAT'S BEING PROPOSED?

The Department of Toxic Substances Control (DTSC) is re-noticing the 45-day public comment period for the draft Hazardous Waste Permit Renewal, Corrective Measure Study, and Proposed California Environmental Quality Act determination for the Safety-Kleen Systems Incorporated, Recycle Center, located at 1000 South I Street in Reedley. DTSC is re-noticing the public comment period because the initial public notice did not run in the local newspaper. To fulfill DTSC's requirement for the draft Permit Renewal, DTSC must announce a 45-day public comment period in a local newspaper. The initial public comment period was scheduled to be published on July 23, 2007 and the public comment period was going to continue through September 6, 2007. However, the new public comment period will begin on August 21, 2007 and will end October 4, 2007.

DTSC is the state agency responsible for regulating the generation, storage, treatment, and disposal of hazardous waste in California. If approved, the renewed permit would allow the facility to continue to store and treat hazardous waste. Safety-Kleen stores paint thinners, paint wastes, used oil, anti-freeze, dry cleaning solvents, and industrial solvents. Safety-Kleen also treats solvents, photo wastes, part washer solvents, and aqueous wastes.

As part of the permit process, DTSC has performed a review of the proposed draft permit renewal as required by the California Environmental Quality Act (CEQA). Based on this review, DTSC has determined that the proposed draft permit will not have any significant effects on public health or the environment. DTSC proposes to issue a CEQA Negative Declaration in connection with this project.
