DTSC Adds Second Contractor to Help Clean Up Properties Near Exide

SACRAMENTO – The California Department of Toxic Substances Control (DTSC) has added a second contractor – Parsons Environment & Infrastructure Group Inc. – to clean up lead-contaminated properties surrounding the now-closed Exide Technologies battery recycling facility in Vernon, California.

“Bringing on Parsons adds an experienced partner to this project and helps accelerate the pace of cleanup to protect the residents in the communities surrounding Exide,” DTSC Director Barbara A. Lee said. “We are unwavering in our commitment to safely and effectively complete the cleanup of these properties.”

With the addition of Parsons, DTSC now has two contractors working on the Exide cleanup. Parsons will remediate up to 1,610 properties in addition to the ongoing work by NEC Construction Inc., whose April 2018 contract was expanded last month to include more properties and a broader geographic area.

The cleanup work will be divided geographically between the two contractors. Under the contract announced today, Parsons will work with Innovative Construction Solutions (ICS) to remediate properties in the cities of Los Angeles and Maywood and in unincorporated East Los Angeles County. NEC’s cleanup work will focus on the cities of Bell, Commerce, Huntington Park, and Vernon.

Both contracts require the contractors to comply with the Project Labor Agreement (PLA) between DTSC and the Los Angeles/Orange County Building Trades Council, which represents 25 craft unions and district councils. The PLA has a specific local-hire approach to extend employment opportunities to communities impacted by the former Exide facility. All employees covered by the PLA will be paid by the employers in compliance with prevailing wage laws.

In addition, both contracts include requirements for hiring graduates of the Workforce for Environmental Restoration in Communities (WERC), a local workforce development program created by DTSC to train and promote hiring of residents in communities near the former Exide Technologies facility. Sixteen WERC graduates are currently employed in the cleanup, and more graduates are expected to fill new positions.

“Terms of the agreement ensure the efficient and timely completion of work and provide job training and long-term economic benefits to the affected communities,” said Francesca Negri, DTSC Chief Deputy Director. “The PLA also realizes DTSC’s commitment to include small businesses and disabled veteran-owned businesses in the project.”

Last year, following extensive public and community outreach, DTSC approved a cleanup plan that calls for cleaning residential properties, schools, parks, and day-care centers with the highest levels of lead in soil and the greatest risk of exposure. The Department’s top priority is protecting the health and safety of people in this area, especially the youngest and most vulnerable.

Ultimately, DTSC will hold Exide and any other responsible parties accountable for the costs of cleaning up the contamination.

In 2016, Governor Edmund G. Brown Jr. signed legislation directing \$176.6 million to expedite the sampling of the approximately 10,000 residential and other sensitive land-use properties and to clean up as many as 2,500 properties with the highest levels of lead in soil and the greatest risk of exposure. This cleanup is the largest of its kind undertaken in California.
