WHAT'S BEING PROPOSED?

The California Department of Toxic Substances Control (DTSC) invites public comment on the draft Removal Action Workplan (RAW) for the Long Beach Unified School District's (LBUSD) Former GTE Property Proposed School Site. This workplan addresses the removal and offsite disposal of approximately 3,400 cubic yards (5,100 tons) of soil from the proposed site. The site is located at 1777 and 1778 East 20th Street in Signal Hill, California. During the site investigation at the 1778 East 20th Street property, polynuclear aromatic hydrocarbons (PAH), hydrogen sulfide and arsenic in soils were detected in concentrations exceeding DTSC health risk levels for school sites. Elevated levels of total petroleum hydrocarbons (chemicals in fuels) and methane were also detected. Therefore, LBUSD proposes to remove the contaminated soil and transport it to permitted offsite disposal facilities. LBUSD also proposes to install a passive venting system for methane mitigation. DTSC has prepared a draft Notice of Exemption (NOE) for this project pursuant to the California Environmental Quality Act (CEQA). This project is considered exempt since it will not have a significant negative impact on the human health and the environment because of the relatively short duration and the controlled manner in which the contaminated soils will be excavated, loaded onto trucks and taken off-site for disposal/treatment.

HOW DO I PARTICIPATE?

This notice is to provide the interested community the opportunity to learn more about the project and provide comments to DTSC about the proposed mitigation during the thirty (30) days public comment period that starts on June 2 and ends on July 1, 2004. Your participation is encouraged. Comments concerning the draft RAW may be given at the public meeting or submitted in writing to Mr. Rao Akula, Project Manager, at the DTSC address listed below, and must be postmarked by July 1, 2004. The open house will be held from 6:30 p.m. to 8:30 p.m. on June 24, 2004, at the Alvarado Elementary School Auditorium, 1900 E. 21st Street, Signal Hill, CA 90755.
