Chemical Dry-Cleaning Removal Action Workplan

30-Day Public Comment Period: June 11 through July 10, 2018

WHAT IS BEING PROPOSED: The Department of Toxic Substances Control (DTSC) invites your comments on a draft Removal Action Workplan (RAW) for a chemically contaminated site, located in a shopping center at 2811 and 2811 ½ E. Lincoln Ave., Anaheim, California 92806 (Property). The purpose of the RAW is to remediate (cleanup) tetrachloroethene (PCE) that was released in soil from past dry-cleaning operations located at the Property. The cleanup is necessary so that indoor air chemical vapor levels will remain protective of public health and the environment.

The former dry cleaner tenant space is currently occupied by a nail salon. To protect the health of nail salon workers in the short term, an interim measures response action was initiated in early 2015 to reduce the level of chemical exposure. In 2016, a pilot Soil Vapor Extraction (SVE) system and proactive building pressurization and ventilation significantly reduced chemical exposure.

The proposed draft RAW recommends the expanded installation and operation of a Soil Vapor Extraction (SVE) system consisting of wells, piping, and an extraction/treatment unit, by which a vacuum is applied to the subsurface to extract PCE vapors from the impacted soil. SVE pilot testing was undertaken in 2016 to assess the effectiveness of the equipment.

CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA): In compliance with CEQA, DTSC has determined that the proposed draft RAW is exempt from CEQA, and a Notice of Exemption (NOE) has been issued for this project.

PUBLIC COMMENT PERIOD: We encourage your participation.
