Marina Bay Project Peninsula Drive and Shimada Friendship Park Richmond, California Field Work Beginning October 16, 2012

The Department of Toxic Substances Control (DTSC) is distributing this work notice to inform the community about upcoming DTSC approved work the City of Richmond will be undertaking in Marina Bay. The work will be conducted in accordance with a June 9, 2011 DTSC approved workplan titled, "Revised Work Plan for additional Soil Gas Evaluation, Area V, Peninsula Drive and Shimada Friendship Park, Marina Bay Project, Richmond, California" (PES Environmental, Inc., 2011), and an event specific workplan dated October 5, 2012 and titled "Well Development Details and Groundwater Sampling Procedures for Groundwater Monitoring Well WTU-1" and "Soil Gas Sampling Procedure for Supplemental Soil Gas Investigation at Shimada Park".

WHAT WORK WILL BE DONE?

The work is part of an on-going soil gas investigation and includes the sampling of soil gas via probes installed in August 2012 along the western boundary of Shimada Park and groundwater from a monitoring well also located in the park.

Work is expected to begin on October 16, 2012 and continue through October 18, 2012. It will be completed during normal business hours (8:00 AM to 5:00), Wednesday through Friday. If the weather permits, the work will be done in one day. Residents should expect to see:

- A golf-cart sized vehicle carrying equipment into and out of Shimada Park
- A mobile laboratory in the parking lot
- Workers collecting samples
- Workers operating hand-held power tools

PLEASE DON'T WATER YOUR LAWNS!

We ask all residents facing the western side of Shimada Friendship Park, to **refrain from watering lawns, backyards and/or landscaping** between October 10, 2012, and October 18, 2012. Wet soils can degrade the quality of soil gas samples.
