Update on Re-Sampling of Riverside Agricultural Park & Notice of Additional Cleanup

Why This Notice? Our agency, the Department of Toxic Substances Control (DTSC), provided lead regulatory oversight of the removal of soil contaminated with polychlorinated biphenyls (PCBs) at the Riverside Agricultural Park property, located at 7020 Crest Avenue in the city of Riverside. DTSC is a department within the California Environmental Protection Agency, and is responsible for overseeing environmental activities at sites such as the Riverside Agricultural Park (Ag Park). The property is vacant and fenced land bordered by Crest Avenue, Rutland Avenue and the Santa Ana River. The property is currently planned for residential development. Due to high community interest and concern, DTSC has been collaborating with the United States Environmental Protection Agency (US EPA) on additional steps needed for the Ag Park.

November Sampling Results

In November, we informed you that environmental sampling activities had been conducted at the Ag Park on November 2 and 3, 2015. A total of 176 samples were collected, and results indicate consistent, low-level PCB concentrations for a majority of the property with some elevated areas that will need to be dug out and removed. Families living around the Ag Park, and people who use the Santa Ana River recreational trail are not at risk. However, some areas will require removal prior to building new homes and to ensure the long-term safety of residents moving in.

Notice of Upcoming Additional Cleanup Activities at Riverside Ag Park

Based on the November 2015 sampling discussed on the previous page, DTSC and US EPA decided an additional cleanup of soil is needed at the Ag Park if the Site is developed for residential purposes. The proposal for cleanup, which includes the removal of any known PCBs found above the original cleanup level of 0.22 mg/kg, will be conducted in accordance with the Response Plan that was approved by DTSC in 2006. The 0.22 mg/kg used throughout the project is a conservative cleanup goal and lower than the level at which EPA and DTSC consider health protective in a residential setting, and within both agencies' acceptable risk range. Additional details are outlined in the January 2016 Soil Sampling and Excavation Plan.

Here is some information regarding the proposed cleanup:

Soil Removal Amount:	~8,000 to ~15,000 tons
Cleanup Duration:	April –June/July 2016
Work Hours:	7:00 am – 5:00 pm Monday – Friday & 8:00 am – 4:00 pm on Saturdays
Truck Traffic:	About 60-80 trucks will enter/exit the property per work day during soil removal, with about ~350 - ~550 total truckloads

Dust Control

The following actions will be implemented during this cleanup to ensure public safety and minimize dust:

1. Driving all vehicles at slow speeds while on the property
2. Spraying of work areas with clean water to control dust
3. Cover soil stockpiles with plastic sheeting
4. Masks and protective clothing worn by on-site workers
5. Securing trucks with covers before they leave the property
6. Truck tires entering and exiting the property will be brushed to remove soils and debris
7. South Coast Air Quality Monitoring District has provided feedback on monitoring air to ensure dust stays at safe levels
8. Compliance with all applicable South Coast Air Quality Management District requirements

Truck Route

1. Truck entrance/exit is located on Jurupa Avenue
2. East on Jurupa Avenue to Van Buren Boulevard
3. Van Buren Boulevard to the 60 Freeway

Sampling

Additional investigative sampling will occur prior to approval of the cleanup proposal. Confirmation samples will be collected during and after removal is completed to ensure that the Riverside Ag Park is safe for residential development.

Cleanup Plan Available for Public Review

The cleanup plan, "January 2016 Soil Sampling and Excavation Plan", will be available for public review from March 7th through March 21st 2016.
