This Report presents the results of the chemical contamination investigation done in the Building 009 Leach Field, Building 056 Landfill, the Empire State Atomic Development area, and the Former Sodium Disposal Facility. These areas are located in western portion of administrative Area IV of the Santa Susana Field Laboratory in the Simi Hills of Ventura County.

DTSC placed this Report and associated historical documents on the Santa Susana Field Laboratory Website in September 2007.
