## THE GROUP 3 REMEDIAL INVESTIGATION (RI) REPORT SANTA SUSANA FIELD LABORATORY SIMI HILLS, VENTURA COUNTY



**Public Comment Period: October 21, 2009 – December 4, 2009**

The Department of Toxic Substances Control (DTSC) invites you to review and comment on the Group 3 Remedial Investigation (RI) Report. The Group 3 RI Report is the seventh of eleven investigations reports for the Santa Susana Field Laboratory (SSFL). Previous investigation reports were formerly called RFI Reports. The name change is due to the passage of Senate Bill 990 in 2007, which shifted the statutory requirements to Chapter 6.8 of the California Health and Safety Code, and changed some of the terminology of the documents and processes. The Group 3 RI Report presents the results of the chemical contamination investigation done for seven sites within the Santa Susana Field Laboratory (SSFL). Six sites are on NASA owned portion of the SSFL and include Building 204 Underground Storage Tanks (USTs), the Storable Propellant Area (SPA), the Alpha/Bravo Fuel Farm (ABFF), the Bravo area (including the test stands), the Alpha Area (including the test stands), and Skyline Road. One additional site located in the Group 3 area is on property owned by Boeing and is known as the Waste Coolant Tank (WCT). These sites are all located in the central portion of SSFL. The RI Report was submitted to DTSC by NASA and The Boeing Company (Boeing) as required by a 2007 consent order. DTSC welcomes your comments and will consider them before preparing comments to NASA and Boeing. These Reports provide a basis for evaluation of future cleanup activities.
