The Department of Toxic Substances Control (DTSC) invites you to review and comment on the Site-Wide Water Quality Sampling and Analysis Plan (WQSAP). This Plan presents methodologies for sampling, analysis, and reporting for the Site-Wide groundwater quality monitoring at the Santa Susana Field Laboratory (SSFL). The Site-Wide WQSAP establishes a system that supports the overall groundwater investigation and remediation strategy to SSFL by establishing a groundwater quality data collection program that is consistent with State and Federal cleanup laws and policies. Both filtered and unfiltered samples will be collected and analyzed for chemicals and radionuclides.
