## **BROWNFIELDS INITIATIVES**

To help address brownfields in California, the Department of Toxic Substances Control (DTSC) has developed a number of initiatives using a variety of administrative and legislative tools and integrated existing tools within the Site Mitigation and Brownfields Reuse Program.

- Voluntary Cleanup Program: Established in 1993, DTSC's Voluntary Cleanup Program allows motivated parties who are able to fund the assessment and/or cleanup and DTSC's oversight to move ahead at their own pace to investigate and remediate their sites. Further information is available at:

- EnviroStor: The new Site Mitigation and Brownfields
  Reuse Program database, EnviroStor, is an online search
  and Geographic Information System tool for identifying sites
  that have known contamination or sites for which there may
  be reasons for further investigation. Searches may be
  conducted by site name, address, city and county or by

- Redevelopment Agency Process (Polanco Act -AB 3193 & SB 1425): DTSC and the California
  Redevelopment Association have jointly developed an
  Environmental Oversight Agreement to facilitate the
  environmental assessment, cleanup and reuse of
  brownfields sites by Redevelopment Agencies throughout
  California. This program establishes a collaborative
  process that: (1) provides flexibility to address the specific
  needs of redevelopment agencies; (2) ensures the
  investigation and cleanup are conducted in an

environmentally sound manner and results in a property safe for redevelopment; and (3) provides liability relief for redevelopment agencies that complete the site characterization and cleanup process if the cleanup is conducted in accordance with a remedial action plan approved by DTSC, a Regional Water Quality Control Board (RWQCB), or a local agency. - Management Memo #92-4, Approval of a Partial Site Cleanup (April 1992): Allows issuance of a "clean parcel letter" for sites where a designated portion of the property has been cleaned up. - Unified Agency Review of Hazardous Materials
  Release Sites (Site Designation -- AB 2061):
  Established the Site Designation Committee process in
  1994 to minimize and/or eliminate the duplication of effort
  of State and local regulatory agencies involved in the
  oversight of site cleanups by designating a single
  "administering agency" to oversee response actions for a
  site if petitioned by a responsible party. Requires
  coordination of all State and local agencies with
  jurisdiction and issuance of a certificate of completion.

- Mello-Roos Community Facilities Act Amendments
   (AB 2610): Created first long-term financing options for hazardous substances cleanup by empowering Community Facilities Districts to levy special taxes and issue bonds to provide funds for site cleanups. Further information is available at:

- Brownfields Targeted Site Investigation Program: The Targeted Site Investigation (TSI) program is one of the several initiatives funded through a \$1.5 million grant from the United States Environmental Protection Agency.

## Brownfields Initiatives California Environmental Protection Agency DEPARTMENT OF TOXIC SUBSTANCES CONTROL

Government agencies and non-profit organizations involved with redevelopment in California are eligible for funding assistance under this program. Brownfields are properties that may be contaminated and underutilized due to potential remediation costs and liability concerns. DTSC, in collaboration with the RWQCBs, will select a limited number of sites and use TSI funds to perform site investigations at no cost to the applicant. - Prospective Purchaser Policy: Includes a model Prospective Purchaser Agreement (with covenant not to sue) and eligibility criteria. - Local Agency Oversight of Cleanups (SB 1248): Allows a responsible party and a local health or environmental health agency to enter into a written agreement for the supervision of the cleanup of a simple waste release. Local agencies are required to notify DTSC and the local RWQCB at least 10 working days prior to entering into a remedial action agreement. Further information is available at:

- California Land Environmental Restoration and Reuse Act (SB 32): Passed in 2001, SB 32 established a local agency hazardous materials cleanup program. It also required the California Environmental Protection Agency to provide a variety of information related to brownfields cleanups and to develop a set of 54 screening values called California Human Health Screening Levels or CHHSLs for hazardous substances commonly found at brownfields sites.   - Hazardous Material Liability of Lenders and Fiduciaries (SB 1285): Provides limited liability exemption for lenders and fiduciaries for releases of hazardous materials on property in which they have a legal interest, but did not "directly" cause or contribute to the release or potential release of a hazardous substance. http://www.dtsc.ca.gov/SiteCleanup/Brownfields/index.cfm# CP\_JUMP\_13318  Revolving Loan Fund Program: DTSC is working with the City of Los Angeles and the Redevelopment Agency of the City and County of San Francisco to establish the coalition referred to as California's Urban and Rural Brownfields (CURB) Coalition. The CURB Coalition, with DTSC as the grant recipient, is seeking to capitalize a Revolving Loan Fund (RLF) Program to provide loans and subgrants to communities within the State to support cleanup activities at contaminated urban and rural brownfields sites. The requested \$2,500,000 for hazardous substances sites and \$500,000 for petroleum sites (for a total of \$3,000,000) will provide loan or subgrant funding for cleanup of a number of brownfields sites over the next five years. The exact number of sites to be supported by this program is dependent upon the amount of funding provided in each loan/subgrant. CURB also anticipates using a portion of the funds to establish a loan guarantee program. Further information is available at:

Management Memo #90-11, Responsible Party Ownership of Property Over Contaminated Ground
 Water (December 1990): Ensures owners of property
 onto which a plume of contaminated groundwater has
 migrated that they will not become a target of enforcement
 or cost recovery action solely on the basis of land
 ownership provided they do not cause or contribute to
